

THE SPORTS ACADEMY NW RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT ("AGREEMENT")

This Agreement is being entered into in consideration of my participation on/in _____ ("Activity/Program") or any other Activity/Program, and hereby represent that I understand the nature of such Activity/Program and that I am qualified, in good health, and in proper physical condition to participate in such Activity/Program. I acknowledge that if I believe event conditions are unsafe, I will immediately discontinue participation in the Activity/Program. I fully understand that this Activity/Program involves risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my own actions, or inactions, those of others participating in the event, Activity/Program, the conditions in which the event, Activity/Program takes place, or the negligence of the "releases" named below; and that there may be other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, cost, and damages I incur as a result of my participation in the Activity/Program.

I hereby release, discharge, and covenant not to sue The Sports Academy - Northwest its respective administrators, directors, agents, officers, volunteers, and employees, other participants, any sponsors, advertisers, and, if applicable, owners and lessors of premises on which the Activity/Program takes place, (each considered one of the "RELEASEES" herein) from all liability, claims, demands, losses, or damages, on my account caused or alleged to be caused in whole or part by the negligence of the "Releasees" or otherwise, including negligent rescue operations and in the future agree that if, despite this release, waiver of liability, and assumption of risk, I, or anyone on my behalf, make a claim against any of the Releasees, I will indemnify, save, and hold harmless, each of the Releasees from any loss, liability, damage, or cost, which any may incur as the result of such claim. Permission is also given to use my child's photo or endorsement for promotion.

The parties agree that the substantive laws of the State of Wisconsin shall govern all matters concerning the validity, performance, administration, and interpretation of this Agreement. The parties further agree that any judicial proceeding brought against The Sports Academy - Northwest on account of any dispute arising out of the Agreement, or any matter related hereto, shall be brought in the courts of the State of Illinois or federal courts sitting in the State of Illinois.

If any term, part, or provision of this Agreement is declared illegal or invalid by a court of general jurisdiction or is superseded by a specific law or regulation, such law or regulation, such law or regulation shall control to the extent of such conflict without affecting the remaining provisions of this Agreement and the rights and obligations of the parties.

I have read the RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT, understand that I have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this Agreement is held to be invalid the balance, notwithstanding, shall continue in full force and effect for a period of one (1) year from the date hereof.
